NEW PUSH TO UPGRADE ECONOMIC DATA SOURCING

MoSPI introduces new system to monitor emerging sectors

New Delhi, November 18

AS PART OF efforts to widen and modernise the sourcing of economic data, the Ministry of Statistics and Programme Implementation (MoSPI) on Tuesday unveiled the National Industrial Classification (NIC) 2025 — a comprehensive overhaul aimed at capturing emerging industries such as digital platforms, renewable energy, and intermediation services.

The updated classification aligns with the International Standard Industrial Classification of All Economic Activities (ISIC) Revision 5 developed by the United Nations Statistics Division and has been prepared by the National Statistics Office (NSO) to categorise activities across industries more precisely.

A key feature of NIC 2025 is the introduction of a six-digit India-specific coding structure, replacing the existing five-digit system. The new framework enhances the coverage of environmental and green economy activities while

distinctly classifying digital economy services. According to MoSPI, "cloud infrastructure, blockchain, platform-based services, and web search portals are distinctly classified, reflecting the evolving nature of the digital economy."

The ministry said the NIC will serve as a vital statistical standard for compiling and analysing economic indicators across sectors. "New classes have been created across multiple sections to reflect the growing role of intermediaries

in sectors such as power, retail, logistics, healthcare, education, real estate, and food services," it added.

The latest classification expands to Sections A to V (previously A to U), with several sections reorganised to reflect new economic realities. For instance, digital and IT services are now divided across Sections J and K, while repair and intermediation services have been placed in new divisions and groups.

Wholesale and retail trade of motor vehicles ceases to be a

separate division and is now merged into the respective divisions for wholesale and retail trade. Repair of motor vehicles has also been merged with the repair and maintenance of computers, personal and household goods.

India's classification system, first introduced in 1962, has undergone several revisions in line with global standards and the evolving economy — resulting in NIC 1970, NIC 1987, NIC 1990, NIC 1998, NIC 2004, and NIC 2008.

"Zero tolerance": Jaishankar on terrorism at SCO meet

INDIA ON TUESDAY said that the world must display "zero tolerance" towards terrorism in all its forms and manifestations, asserting that there can be no justification, no looking away and "no whitewashing".

"As India has demonstrated, we have the right to defend our people against terrorism, and will exercise it," External Affairs Minister S Jaishankar said in his address at the Shanghai Cooperation Organisation (SCO) Council of Heads of Government meeting. Jaishankar said India believes that the SCO must "adapt to the changing global landscape, develop an expanded agenda, and reform its working methods". "We will contribute positively and fully to these objectives," he said.

The SCO was founded at a summit in Shanghai in 2001 by the presidents of Russia, China, the Kyrgyz Republic, Kazakhstan, and Pakistan and Uzbekistan. India and Tajikistan became its permanent members in 2017. In July 2023, Iran became the new permanent member of the SCO at an India-hosted virtual summit of the grouping. "We must never forget that the SCO was founded to combat the three evils of terrorism, separatism and extremism. These threats have become even more serious in the years that have passed," he said.

"It is imperative that the world displays zero tolerance towards terrorism in all its forms and manifestations. There can be no justification, no looking away and no whitewashing," the EAM said.

Jaishankar also emphasised on the prevailing economic situation globally and the importance of fostering greater cultural ties in the influential bloc. "We assess the global economic situation to be particularly uncertain and volatile currently. Supply side risks have been aggravated by demand side complexities. There is consequently an urgent requirement to de-risk and diversify. This is best done by as many of us, forging the widest possible economic links," he said.

For that to happen, it is essential that this process be "fair, transparent and equitable," the EAM said.

"India's endeavours to conclude free trade agreements with many of us here are relevant," Jaishankar said. And, India's long-standing ties with SCO members makes it particularly pertinent, he added.

Jaishankar on Tuesday called on Russian President Vladimir Putin along with other heads of delegation of SCO member states. "Called on President Putin along with other Heads of SCO Delegations this afternoon," Jaishankar said on social media.

The meeting in the Kremlin was also attended by Russian PM Mikhail Mishustin, Iranian Vice President Mohammad Reza Aref, Prime Ministers Alexander Turchin of Belarus, Oljas Bektenov of Kazakhstan, Adybek Kasymaliyev of Kyrgyzstan, Kokhir Rasulzoda of Tajikistan and Abdulla Aripov of Uzbekistan, as well as Pakistan Deputy PM Ishaq Dar and SCO Secretary General Nurlan Yermekbayev.

India for alliance with UAE in defence sector

MINISTER OF STATE for Defence Sanjay Seth, who held a bilateral meeting with his UAE counterpart Mohammed Mubarak Al Mazrouei, has urged that the two sides should "explore" joint research and co-development, and co-production in the defence sector.

The meeting took place on Monday, on the sidelines of the Dubai Air Show.

Seth chaired an industry roundtable on the theme "Defence Technology Collaboration and Manufacturing in India" on the second day of his visit to Dubai on Tuesday.

A total of 50 global and Indian industries participated in the event.

In his address, the Union minister highlighted the strength of Indian defence manufacturing capabilities and expanding the defence ecosystem.

He encouraged the companies to explore joint ventures and emerging opportunities for collaborations in India, the defence ministry said in a statement. On the first day of his visit, Seth held a bilateral meeting with his UAE counterpart, on the sidelines of the Dubai Air Show.

The Union minister emphasised the importance of interaction between the two sides through institutional mechanisms, participation in defence exhibitions and training cooperation. He urged the two sides to "explore joint research and co-development, and co-production in the defence sector".

Seth later inaugurated the India Pavilion where Defence Public Sector Undertakings and private industries like Hindustan Aeronautics Limited, Defence Research and Development Organisation, Corel Technologies, Dantal Hydraulics, Image Syn-ergy Eksplo, SFO Technologies and several defence start-ups have put up their stalls.

Bullet train's inaugural run to cover 100 km

● Train will run between Surat & Vapi: Vaishnaw

INDIA'S FIRST BULLET train will now cover a 100 km distance between Surat and Vapi in Gujarat during its inaugural run in August 2027, Railway Minister Ashwini Vaishnaw said on Tuesday.

Earlier, Vaishnaw had said that the inaugural run would happen on a 50 km stretch between Surat and Billimora.

The country's first 508-km long high-speed rail corridor is being constructed between Sabarmati (Ahmedabad) and Mumbai to operate a bullet train at 320 kmph, covering the entire distance in 2 hours and 17 minutes.

Its foundation stone was laid in 2017 and the entire project was initially proposed to be ready by December 2023. However, land acquisition and other issues delayed the ambitious project.

"The bullet train, in its inaugural run, will now cover



100 km between Surat and Vapi in August 2027. Earlier, the inaugural run was planned on a 50 km stretch between Surat and Billimora within the same deadline," Vaishnaw told reporters at the Rail Bhawan.

"The bullet train will cover the distance between Mumbai and Ahmedabad in 1 hour 58 minutes while stopping at four stations. However, if it stops at all 12 stations, the entire distance will be covered in 2 hours and 17 minutes," he added.

Speaking about Prime Minister Narendra Modi's recent visit to upcoming Surat station, Vaishnaw said that the PM was very happy with the pace of construction.

"PM Modi said that whatever we have learnt from the project must be used elsewhere, not only in Railways and other high speed projects, but in other different sectors as well. We have done one innovation after the other in this project," Vaishnaw said.

"It is a complex project and the biggest challenge was its design," he added, emphasising that the entire project will be operational by the end of 2029.

Despite Vaishnaw's new commitment to the bullet train's inaugural run, there remains a lack of clarity on the type of train which will operate on its first run.

ED arrests Al Falah group chairman

THE DIRECTORATE OF Enforcement (ED) on Tuesday arrested Jawad Ahmed Siddiqui, chairman and managing trustee of Al Falah Charitable Trust and Al Falah Group, in connection with a money laundering case. Siddiqui was taken into custody under Section 19 of the Prevention of Money Laundering Act (PMLA), 2002.

The arrest came after coordinated raids at 19 locations across Delhi-NCR, including Al Falah University in Faridabad and the residences of several key individuals.

During the searches, the ED seized over ₹48 lakh in cash, multiple digital devices, and incriminating documents. Al Falah University has been under scrutiny following the busting of a "white-collar" terror

module and the November 10 blast near the Red Fort, which claimed 15 lives.

The ED investigation is based on two FIRs registered by the Delhi Police, alleging that Al Falah University falsely claimed NAAC accreditation and UGC recognition under Section 12(B) to mislead students and parents. The UGC has clarified that the university is only listed under Section 2(f) and therefore ineligible for central grants.

The agency has also alleged large-scale generation and diversion of proceeds of crime, including the routing of funds through shell companies and awarding contracts to entities owned

by Siddiqui's wife and children. Siddiqui was produced before a special court, where the ED sought his remand.

"The role of Siddiqui in effectively controlling the trust and its activities has been brought out by multiple pieces of evidence," an ED official said.

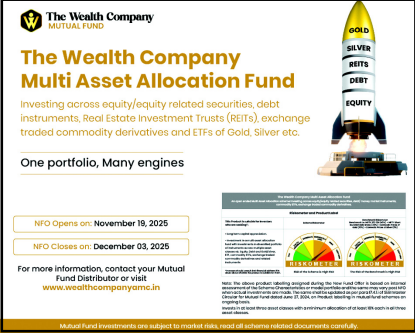
